- E. Questions & Clarifications GENERAL
 - Bonds. No trade needs to include a Performance & Payment Bond in their bid, however
 the bond rate shall be included on the Bid Form. The intention is for all trades to be
 enrolled in a Subcontractor Default Insurance Program. If denied enrollment by the
 program administrator, the Subcontractor will be reimbursed for the cost of providing a
 Performance & Payment Bond.
 - Bid Security (Bid Bond). In accordance with the NC General Statute <u>ALL</u> trades shall
 include a Bid Security equal to 5% of the submitted Base Bid in the sealed envelope
 package to be opened publicly and read aloud.
 - 3. *Alternates*. If an alternate is not applicable to your scope of work the bid form includes instructions for addressing that condition write "No Change" in the "Amount" field.
 - 4. Allowances. Allowance specified in the work scope and in the bid breakdown shall be carried in the Base Bid amount but shall NOT be used to cover work described in the Technical Scope of Work. These allowances are in addition to that work and shall be used only with authorization from Barton Malow Company.
 - Combination Bid Packages. There are no combination work scopes advertised for this bid package. If a contractor can offer incentive to be awarded multiple work scopes, it is suggested to include those options as voluntary alternates within each bid form, respectively.
 - 6. *Project Limits*. The project scope limits for the entire project are depicted on C-2.0. In general, the boundaries of the work are:
 - Back of Curb on West B
 - Back of Curb on Chesnut (see C-2.3)
 - Back of Curb on Laureatte
 - Up to the Limits of Work line adjacent to the Parking Deck project
